

LEMOORE ELLYSON RV PARK RULES & REGULATIONS

Thank you for choosing us for your stay! To ensure the enjoyment of all our guests, please see below for park rules:

PATRON ELIGIBILITY: Valid ID required upon check-in, the following patrons are eligible to stay at Lemoore Ellyson RV Park:

- Armed Forces Active Duty personnel and their families
- Armed Forces Retirees and their families
- Reservists and their families
- DoD Civilians (both APF and NAF)
- Honorable-discharged veterans with a service-connected disability
- Medal of Honor Recipients
- Un-remarried surviving spouse of personnel who died while on Active Duty
- Un-remarried surviving spouses of personnel who died while in a retired status
- Un-remarried former spouses who were married to military members for at least 20 years while the military member was on active duty to the Armed Forces

RESERVATIONS: Active Duty personnel may reserve up to one year in advance. All other eligibilities may reserve up to six (6) months in advance. A valid credit card is required for all reservations. Reservations of up to thirty (30) days may be made through:

CANCELLATIONS: Cancellation fees will be charged to patrons who no-show or that do not cancel within fourteen (14) days of arrival.

GUEST OCCUPANCY: Maximum of four (4) guests per site.

LENGTH OF STAY LIMIT: The Ellyson RV Park has designated short-term and long-term spaces to support a variety of lodging needs. Lemoore-assigned Active Duty are permitted to stay with us in a long-term space for the length of their assignment – as space permits. For inquiries on long-term stays, please call (559) 998-0850. All other eligibilities may stay with us up to thirty (30) days or upon approval of a formal request to extend your stay. Duplicate reservations may not be used to circumvent policy.

ACCEPTABLE VEHICLES: An RV is defined as a registered and licensed self-contained vehicle designed to be lived in. Acceptable examples are self-propelled A/C motorhomes, travel trailers (hitch or 5th wheel), pickup truck-mounted self-contained campers, factory-manufactured/converted vans or motorhomes. SUVs, pickups with shells, commercial tractor-trailer rigs and non-factory converted vans and buses will not be eligible for a site rental. Vehicles must be well-maintained and will be denied camping privileges based on unsightly appearance. The Ellyson RV Park reserves the right to deny access to any RV based on its appearance and condition.

BASE ACCESS: Service-connected veterans solely in possession of a Veteran Health Identification Card must arrange for base access in advance of their stay and for all guests. Recommended lead time is one (1) week for Naval Air Station Lemoore. Patrons will need to complete SECNAV Form 5512/1 and submit to nael_pass_id@us.navy.mil. For questions or access request updates, please call (559) 998-3386 or (559) 998-4786.

SITE ASSIGNMENTS: Please do not occupy a site without confirmation. Use only your assigned site. Patrons will receive a call 24 hours prior to arrival confirming their site assignment. If unsure of your assigned site, please call our office at (559) 998-0850 during normal business hours or our camp host at (559) 981-7902 after hours. Lengths of stay and available sites at time of check-in will determine site assignments. Site change requests must be made to the Park Manager and approved before the move is made. Site changes between short-term and long-term sites will not be permitted. Site assignments may be subject to change WITH notice.

CHECK-IN/ARRIVAL INSTRUCTIONS: Check-in time is at 3pm. Large motorhomes and travel trailers are advised to use caution when visiting our office. The office parking lot has no outlet and is difficult to maneuver.

AFTER-HOURS CHECK-IN: Patrons that have not checked in prior to facility close will receive a phone call providing after-hours check-in instructions. Patrons should check in with the camp host on Site #1 prior to proceeding to their site. The camp host may also be reached at (559) 981-7902.

FEES: RV Park fees must be paid in full upon check-in. With exception to our long-term stay guests, if patrons are unable to pay for the requested reservation in full, the front desk shall adjust the reservation to the number of nights the patron is able to pay. After-hours arrivals will incur an automatic charge of a one night stay.

Patrons permitted lengths of stays over thirty (30) days will be required to pay their fees in-person, by the 1st business day of each month. Payments not received by close-of-business on the 9th calendar day will be issued a notice to vacate on the next business day.

SPEED LIMIT: Speed limit in all areas of Ellyson Park is 5 miles per hour.

PARKING: One (1) personally-owned vehicle (POV) and one (1) RV allowed per site. One motorcycle is also permitted. However, all properties permitted herein must be contained on the site's concrete pad and not block roadways or egress. Dirt bikes are not permitted

onsite. An additional POV may park at the adjacent Ellyson Park or Spuds parking lots. All POVs must display parking passes on vehicle front mirror or dash. Property outside of these allowances are not permitted and will be towed at the owner's expense.

OVERFLOW PARKING: Overflow parking is available to patrons when there are no vacancies onsite. Patrons are required to register with the camp host.

CONDUCT/RESPONSIBILITIES: Patrons are responsible for the safety and conduct of accompanying family and guests and will be held financially responsible for any unpaid fees and/or damages brought about by them. Patrons must demonstrate appropriate conduct towards staff and fellow campers. Please do not walk through other patrons' RV sites.

FACILITY SECURITY: Please keep all facility entryways closed and secure. As a guest staying at a military installation, you are not authorized to distribute or share codes with anyone. Requests for code-sharing should be directed to the office and/or camp host.

ELECTRIC VEHICLE CHARGING: Electric vehicle (EV) charging is strictly prohibited onsite. EV charging could permanently damage your vehicle and the park's electrical system. Patrons will be liable for damage incurred from EV plug-ins. Charging available at the Navy Exchange.

DRESS CODE: Modest dress code is required at all times. Patrons, family members, and guests are expected to be fully clothed when staying in the park.

CHILDREN: Children 12 and younger must have adult supervision at all times. A physical adult presence is required for all Ellyson Park areas.

SCHOOL BUS DROPOFF/PICKUP: School buses are not permitted within the Ellyson RV Park. Children drop-off and/or pick-up must occur offsite.

GROUP GATHERINGS: Patron-hosted meetings, parties and gatherings are not permitted within the RV park areas; however, patrons are encouraged to call the front desk for more information on use of the Ellyson Park Picnic Pavilions.

PETS: Patrons are permitted a maximum of (2) pets during their stay. Pet ownership must comply with both NASL instruction and state/local law, to include current base pet registration and vaccinations as well as restrictions on pet breeds. Rodents, reptiles and livestock are not permitted. Patrons must ensure pets are not a disturbance to neighboring sites. All pets must be under direct control of their owner and on a physical leash of no longer than six (6) feet when outside. With the exception of service animals, pets are restricted from facility use to include our bathhouse, laundry room, Ellyson Park Picnic Pavilion and Ellyson Park Driving Range. With weather-permitting, pet tethering is allowed. Pet owners must ensure the tether is short enough as to not reach neighboring sites and may not use Ellyson Park landscaping, equipment, fixtures, or foundation as a tethering point. Pet enclosures, dog runs, gates and/or fences are not permitted. The Ellyson Dog Park is available for your convenience and for a leash-free experience. In consideration of pest and animal control, patrons may not leave food or food bowls unattended outside of feeding times. Pet waste must be immediately collected, bagged and disposed of via your site's waste receptacles or pet waste stations provided throughout the park.

NOISE POLICY: Quiet hours are from 10pm to 8am daily. Generators must be turned off during quiet hours. Excessive noise will not be permitted at any time. Please be considerate of your neighbors. Management and camp hosts will determine 'excessive noise' and take corrective action as necessary.

MAIL AND PACKAGE DELIVERY: USPS and package delivery are not authorized at the Ellyson Park nor the MWR Community Recreation Office. Fedex and UPS are permitted to deliver to your site. See the front desk for more information.

CAMPFIRES/OUTDOOR COOKING: Per NASL instruction, campfires and fire pits are not permitted. Propane grills are permitted but must be at least 10' from any vehicle, RV or structure. Commercial-sized grills are not permitted.

PICNIC TABLES: Picnic tables are available by site for patron use. **Tables must remain on their designated concrete pad. The concrete pad may not serve as vehicle parking.**

PROHIBITED ITEMS: No person shall possess, conceal about his/her person or vehicle, use, or have under his/her control the following items (except when authorized by the Installation Commanding Officer in connection with required Navy duties), including but not limited to:

ITEMS TO DECLARE: While permitted, please notify Ellyson Park Management if you possess the following items: flare guns and knives with blades of 2.5" or longer.

ILLEGAL DRUG USE: Using marijuana and any drugs that are considered illegal by the Federal Government are strictly prohibited in a military installation to include Ellyson Park. Illegal drug use will result in termination of your reservation and a report to base security.

TENTS/CANOPIES: Patrons are permitted (1) not-to-exceed 10' x 20' tent/canopy per site and that of which does not encroach on neighboring sites. Tents/canopies must: be temporary in nature, manufactured with the ability to collapse in less than 10 minutes and staked into the rock or weighted for safety. Tent/canopies may not be enclosed with the exception of 100% mesh siding. Tents/canopies may not be used as shelter/overflow storage of personal items. Sites must remain tidy and clutter-free with canopy use.

SITE UPKEEP: Patrons are expected to keep their sites reasonably well kept and ensure that their site is not accumulating excessive clutter. Site upkeep is at the manager's discretion.

PARKING LOT USE: The Spuds and Ellyson Park Parking Lots are for vehicles only. Equipment such as bicycles, scooters, skates, skateboards, etc. are not permitted in these areas as well as the Ellyson Park Picnic Pavilion.

LAUNDRY FACILITY USE: Please clean up after use. No oversized or pet items in facility washers and dryers. Please see the front desk or camp host for the base laundry-mat location. Please do not leave your items unattended. Laundry left unattended for more than twenty-four (24) hours will be disposed of. The park is not responsible for unattended items. The facility code must not be shared with non-patrons. Non-patrons should be reported to the front desk. Please do not prop the laundry room door open. Outside clothes-drying is not permitted anywhere onsite.

TRASH/WASTE/HAZARDOUS MATERIAL HANDLING: Ellyson RV Park provides weekday trash pickup. Trash must be placed inside the trash receptacle. Site trash must not be discarded in/out of the restroom, shower or laundry facility. Overflow trash must be disposed of in the dumpster adjacent to the Ellyson parking lot. Please break down boxes prior to dumpster disposal. Do not leave trash outside of the trash can or dumpster. Do not place large and/or bulky items in the dumpster.

Please do not dispose of hazardous material at site receptacles or facility dumpster. See the front desk for assistance with proper hazardous waste disposal. Hazardous waste includes, but is not limited to: motor oil, antifreeze, batteries, aerosol cans, ammunition, cleaning products and medical waste.

RV/VEHICLE WASHING & MAINTENANCE: The washing, maintenance and repair of RV and/or vehicles, by patron or commercial entities are strictly prohibited onsite. The MWR Car Wash (with RV wash bay onsite) is available for your convenience. Referrals for local RV maintenance are available upon request.

NO SOLICITATION: It is strictly prohibited to sell/rent goods or services on Ellyson Park property. It is also not permitted to install and/or openly display any political organization, organization affiliation, social interest, media matters, or any content symbols or messages prohibited by Federal, DoD or Navy policy.

VIOLATION NOTICES: Patrons will be cited for violations that occur while staying onsite. MWR will issue up to three (3) violation notices. The third notice will result in termination of stay without refund and possible forfeiture of future camping privileges. Notices are maintained on file for a period of one year from the issuance date.

CHECK-OUT/LATE CHECK-OUT/EARLY DEPARTURE: Check-out time is at 11am. Upon departure, please ensure the water is turned off, sewer lines have been capped and that electrical outlet covers are closed. All patron vehicles, equipment and personal items must vacate the facility by 11am on the departure date, else, the patron will be charged fees equivalent to one additional night and subject to tow. Early departures require 24-hour (11am on the day before the desired departure date) advance notice to avoid being charged an additional night.
