**The MWR Deployment Lot is designed for storage of primary vehicles (cars, trucks and motorcycles) only. Recreational vehicles, trailers, and boats are not authorized.**

The above described vehicle will be stored on a six (6) month deployment basis, whether the deployment is shortened or extended. Prorating of fees are not available. The fee is \$25 per deployment, paid in advance of departure. Vehicles must be picked up within 14 days of deployment return, for each additional day a \$3 per day fee will be charged. The vehicle will be located in the main deployment compound. The renter understands that the fees are for the space, whether or not the vehicle is parked in deployment lot or not (early return).

**TERMINATION:** This agreement will remain in effect until terminated in person or in writing by the registered owner, or by the MWR Department. It is the renter's responsibility to cancel this agreement when vacating the space.

**HOLD HARMLESS:** The renter understands that the MRW Department shall ensure that the compound is fenced and remains locked when employees or authorized personnel are not in the compound. Renters who store their vehicles understand that they are solely responsible for theft, damage, or fire to any vehicle or property located in the compound. The renter agrees to hold harmless the MWR Department, NAS Lemoore, California, and the US Navy for any and all liability for any theft, damage, or fire, or to any persons or property out of or in the course of this agreement.

**ACCESS:** Access to the compound is limited. Prior arrangements must be made with Community Recreation before entering the compound. Absolutely no maintenance or other tasks will be performed in the compound. The vehicle must be removed first.

I have read, understand and agree to abide by the terms and conditions set forth in this agreement. I also agree to keep my space clean, with no other property stored in or around the vehicle. All vehicles stored in the Deployment Lot must be in working condition with current registration and insurance. Any changes will be reported to Community Recreation.

**OTHER THAN FUEL IN THE VEHICLE, NO FLAMMABLE OR HAZARDOUS MATERIALS WILL BE ALLOWED-IN/AROUND THE VEHICLE AT ANY TIME.**
